**CHICAGO, September 10, 2013** - *The Female Health Company* (NASDAQ-CM: FHC - News), which manufactures and markets the *FC2 Female Condom*, today announced that Michael R. Walton retired from its Board of Directors effective September 9, 2013.

Mr. Walton, 76, elected to retire to reduce his workload. He has been a director for 14 years and a long time supporter and early investor in FHC.

O.B. Parrish, Chairman and CEO of The Female Health Company said: "Mike's participation on the Board and support over the years has contributed to the Company's success. I have enjoyed working with Mike, and we will all miss working with him as a Board member."

The patents cover the key aspects of *FC2*, including its overall design and manufacturing process. The *FC2 Female Condom*® is the only available FDA-approved product controlled by a woman that offers dual protection against sexually transmitted diseases, including HIV/AIDS, and unintended pregnancy. The World Health Organization (WHO) has cleared *FC2* for purchase by U.N. agencies.
